

Legal and Privacy Policy

To protect your privacy we provide this notice explaining our online information practices and the choices you can make about the way your information is collected and used.

1. The information we collect

This notice applies to all information collected or submitted on the Countrywide Waste Solutions website. On some pages you can make requests and register to receive materials. The types of personal information collected at these pages are:

2. The way we use information

To prevent unauthorised access, maintain data accuracy and ensure the correct use of information, we have put in place appropriate physical, electronic and managerial procedures to safeguard and secure the information we collect online. We will ensure that all personal information supplied is held securely, in accordance with the Data Protection Act 1998.

4. Cookies

We may use 'cookies' for administrative purposes such as cataloguing traffic patterns throughout the website and can use a cookie to assign a 'user ID' for this purpose. Cookies, by themselves, cannot be used to find out the identity of any user. If you have a user ID this will automatically identify your computer - but not you - to our server when you visit our website. Unless you specifically tell us, we will never know who you are, even if we do assign a cookie to your computer.
